**DEFACING, DESTROYING OR REMOVING ANY SIGN, POSTER, BUILDING, TREE OR OTHER PROPERTY IS PROHIBITED**

**FIRES PERMITTED ONLY IN GRILLS.**

**INTOXICATION, INDECENT LANGUAGE, UNNECESSARY NOISE OR ANY OTHER ACTS OFFENSIVE TO THE PUBLIC IS PROHIBITED**

**LITTERING OR DEPOSITING REFUSE OR RUBBISH ON PARK PROPERTY IS PROHIBITED. ALL REFUSE MUST BE PLACED IN DESIGNATED RECEPTACLES.**

**YOU MUST PLACE RECYCLABLES (MIXED PAPER, GLASS, ALUMINUM, METAL AND PLASTIC IN #1 THRU #7 CONTAINERS, IN THE DESIGNATED RECYCLING RECEPTACLES.**

**ALL CONTAINERS MUST BE RINSED AND CLEAN**

**ALL BAGS OF TRASH MUST BE PLACED IN DUMPSTER**

**NO COMMERCIAL ACTIVITY IS PERMITTED WITHOUT A PERMIT ISSUED BY THE BOROUGH MANAGER**
